Online access to millions of documents is now available



Frequently Asked Questions

Interested in researching the history of your property? Misplace a copy of a recent legal filing? Looking for the covenants and restrictions against your property? As part of a major effort to make the Office of the Westchester County Clerk more accessible to residents of Westchester County, access to millions of documents on file in the Clerk's Office has been enhanced to allow online access for a daily user fee of \$20.00 payable by a credit card. Access from a home or business computer had previously been available only to annual subscribers who paid a \$1,200.00 subscription fee.

Q. What records are available?

A. The records which can be viewed online for a daily fee of \$20.00, payable by MasterCard or Visa, include:

- ▶ Land records including deeds going back to 1680 and mortgages recorded as far back as 1927; and
- ▶ Unrestricted court records including summons, complaints, decisions and orders from cases commenced after January 1, 2002; and

Q. What if I pay the fee and you do not have the record I am looking for?

A. In order to avoid paying the \$20.00 fee only to find out we do not have the record you are looking for, you are encouraged to use the free online public viewer to search our indexes. In addition, please review the List of Available Documents on our website to be sure the imaged document is not sealed or restricted (such as in the case of a matrimonial file). By doing this you can be sure that a document is on file in our office and an image is available before paying the daily user fee to gain access to an online image.

Q. What if I do not want to have to pay to view the document?

A. Charging a user fee of \$20.00 for online access has allowed the cost of developing this option to be borne by the users of the system rather than the general taxpayer. However, the same records can still be viewed without cost in Office of the Westchester County Clerk which is located at 110 Martin Luther King Jr. Blvd. in White Plains and can be reached by entering through the Richard J. Daronco Courthouse. The office is open from 8:00 a.m. to 5:45 p.m., Monday through Friday, excluding legal holidays.
