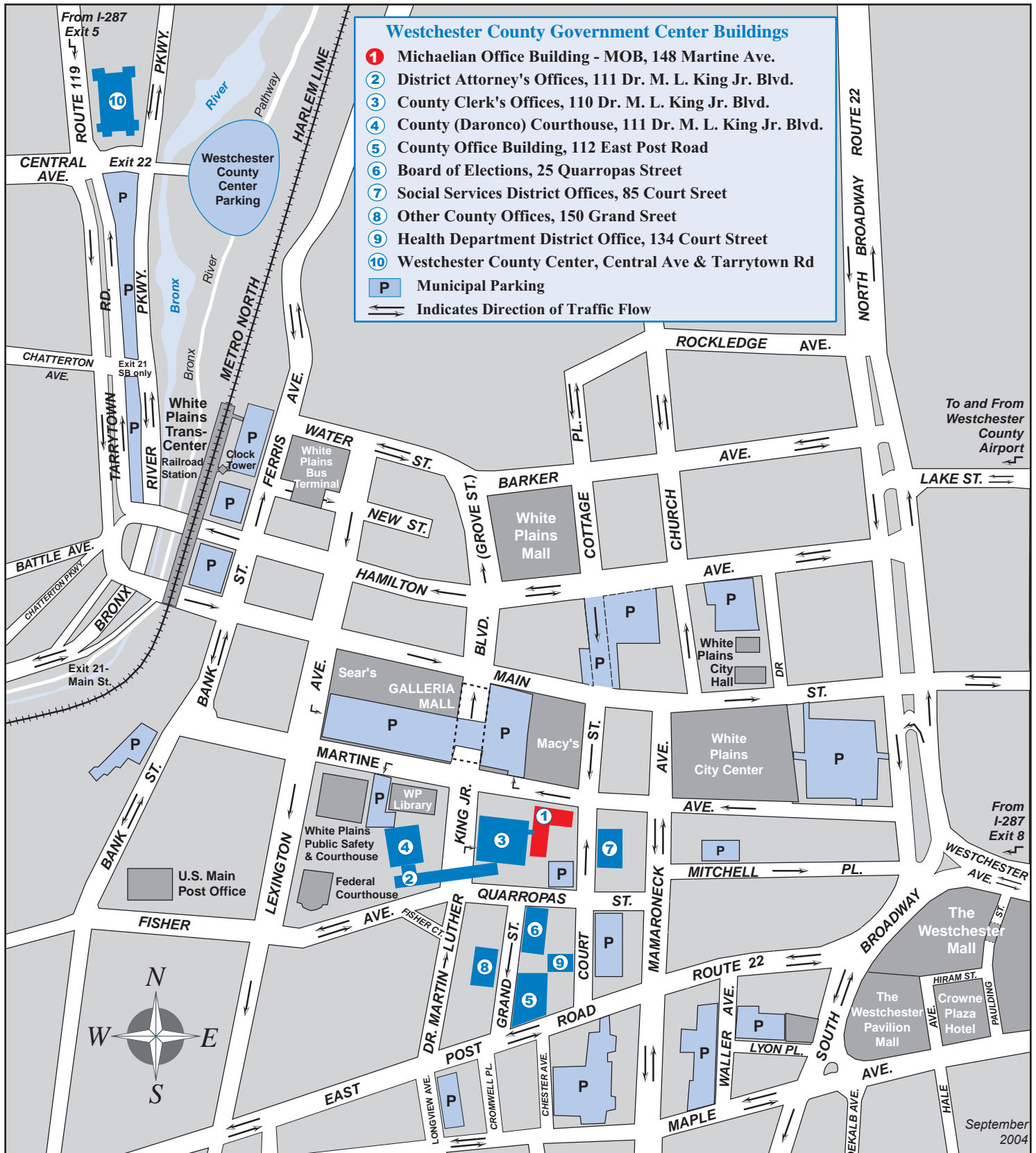


# WESTCHESTER COUNTY GOVERNMENT CENTER DIRECTIONS GUIDE DOWNTOWN WHITE PLAINS, NEW YORK





## **Driving Directions to the Westchester County Government Center, White Plains, New York**

### **FROM PEEKSKILL, CORTLANDT, YORKTOWN**

**Taconic State Parkway** south to the Sprain Brook Parkway to I-287 east (White Plains) exit on the left; continue east on I-287 to Exit 5; merge onto Route 119, Tarrytown Road; follow directions detailed in **(A)** below.

**(A) Continue on Tarrytown Road, Route 119 east which becomes Main St (under the railroad bridge); continue on Main Street for 4 blocks, make right onto Court Street, take one block and make right onto Martine Ave. The Michaelian Office Building is on the left at 148 Martine Ave.**

**Bronx River Parkway** south to Exit 22; right at County Center, White Plains; left at traffic light onto Tarrytown Road (Route 119 east); follow directions detailed in **(A)** above.

**Route 9** south to Route 9A to I-287 east to Exit 5; follow directions detailed in **(A)** above.

### **FROM BEDFORD, LEWISBORO, NORTH SALEM, MOUNT KISCO**

**Saw Mill River Parkway** south to Taconic Parkway to Sprain Parkway to I-287 east (White Plains) exit on the left; continue east on I-287 to Exit 5; right turn at end of ramp onto Route 119, Tarrytown Road; follow directions detailed in **(A)** above.

**Interstate Route 684** south to I-287 west (White Plains) exit; take I-287 west a short distance to Exit 8 onto Westchester Avenue; continue westbound toward White Plains; follow directions detailed in **(B)** below.

**(B) Continue west on Westchester Avenue; after first light stay to the left (Rt. 119) and follow Westchester Avenue into White Plains, passing The Westchester Mall on left; road veers right, but stay to the left up hill (follow sign for "Central Business District"), turn onto South Broadway (Rt. 22), move to far right and make first right at light onto Martine Avenue and go 3 blocks to the Westchester County Office and Courthouse buildings on the left after Court St.**

### **FROM ROCKLAND COUNTY AND UPSTATE NEW YORK**

**New York State Thruway (I-87)** across Tappan Zee Bridge to Exit 8 onto Cross Westchester Expressway (I-287) east to Exit 5; follow the directions detailed in **(A)** above.

### **FROM CONNECTICUT AND NEW ENGLAND**

**Merritt Parkway (CT)** to the Hutchinson River Parkway (NY) to Exit 26, Cross Westchester Expwy. (I-287) west to White Plains; continue on I-287 to Exit 8 onto Westchester Ave; follow the directions detailed in **(B)** above.

**Connecticut Turnpike (I-95)** to Exit 21, Cross Westchester Expressway (I-287) west to White Plains to Exit 8 onto Westchester Avenue; follow the directions detailed in **(B)** above.

### **FROM NEW YORK CITY, LONG ISLAND AND NEW JERSEY**

**George Washington Bridge** to Henry Hudson Parkway north to Saw Mill River Parkway to the New York State Thruway (I-87) to Exit 8; Cross Westchester Expressway (I-287) east to Exit 5; follow the directions detailed in **(A)** above.

**Bronx River Parkway** north to Exit 21 White Plains; make right onto Main Street and proceed 4 blocks to Court Street; make right and take one block to Martine Avenue; make right onto Martine Ave; Michaelian Office Building is on left (#148). Courthouse buildings are one more block on the left.

**Hutchinson River Parkway** north to either alternate **(1)** or **(2)** below:

**Alternate (1) Exit 23 onto Mamaroneck Avenue, White Plains; right turn on Mamaroneck Avenue and continue north approximately 4 miles into the central business area of White Plains to Martine Avenue, left turn on Martine Avenue and proceed 2 blocks; Westchester County Office and Courthouse buildings are on left.**

**Alternate (2) Exit 26 onto the Cross Westchester Expressway (I-287) west to White Plains; continue on I-287 to Exit 8 onto Westchester Avenue; follow the directions detailed in **(B)** above.**

**Bronx Whitestone Bridge** to the Hutchinson River Pkwy north to either alternate (1) or (2) on the preceding page.

**Throgs Neck Bridge** to Throgs Neck Expressway to Bruckner Expressway (I-95) northbound to Hutchinson River Parkway using Alternate (1) or (2) on the preceding page; or continue north on the New England Thruway (I-95) to Exit 21 at the Cross Westchester Expressway (I-287) west to White Plains; continue on I-287 to Exit 8 onto Westchester Avenue; follow the directions detailed in (B) on the preceding page.

## By Train

Take Metro North Railroad (Harlem Division) to White Plains Station. The White Plains Station is within a half mile walk (take Main Street for 3 blocks, make right on Court St., take 1 block to Martine Ave.) or taxi-ride to the Michaelian Office Building and other County offices in Downtown White Plains.
