NOTICE

TO: All Contractors and Subcontractors who enter into or who have contracts to do work with Westchester County

FROM: Westchester County Health Department (WCDH)
Bureau of Environmental Quality

RE: New Westchester County Law
Chapter 873, Article XIII, Section 873.1329
Air Quality; Onroad and Nonroad Vehicles; Emission Standards

Please be informed that as of February 10, 2006 all contractors and subcontractors who enter into an agreement or contract with Westchester County valued at more than \$150,000.00 (amount is increased by \$5000.00 yearly following the Law effective date until it reaches a maximum of \$250,000.00) must conform to the following:

All diesel-powered onroad and nonroad vehicles shall be fueled with the Ultra Low Sulfur Diesel Fuel (ULSDF) having sulfur content of no greater than 15 ppm. In addition, as of September 1, 2009 all diesel powered nonroad vehicles and equipment 50 Hp and greater and all onroad vehicles having a gross vehicle weight rating of more than 14,000 pounds shall utilize an air pollution control device which is categorized as Best Available Technology (BAT) .

Please consult both the Environmental Protection Agency (EPA) Verified Retrofit Technology List at <http://www.epa.gov/otaq/retrofit/verif-list.htm> and California Air Resource Board (CARB) list at <http://www.arb.ca.gov/diesel/verdev/vt/cvt.htm> to ensure that the emission control device has been pre-approved for your type of engine. The BAT selection shall be made in accordance with the Rules and Regulations and New York City Department of Environmental Protection (NYCDEP) Chapter 14 of Title 15 of the Rules of the City of New York concerning the use of ULSDF and Emission Control Technology. Enclosed are monthly summary reports (**Form I** – Vehicle/Equipment Information and **Form II**- Vehicle/Equipment ULSDF usage). Contractors and subcontractors are required to complete and submit to WCDH a list of diesel powered construction equipment/vehicles that will be retrofitted with BAT and that will use ULSDF.
