Possession of a license to practice as a Professional Engineer in New York State may be substituted for all of the required experience.

Construction Coordinator: \$69,960 – 93,255

Required: Associate's of Science Degree\* in Engineering or a closely related field and four years of experience where the primary function of the position was coordinating construction projects which must have involved a minimum of three of the following trades: carpentry, electrical, heating and ventilation, masonry, plumbing or steel or concrete construction.
