### CASE MANAGER II (SUBSTANCE ABUSE)

<u>DISTINGUISHING</u> FEATURES OF THE CLASS: Under general supervision, an incumbent of this class is responsible for counseling and conducting outreach activities as part of a comprehensive professional program designed to provide evaluation and case management services for patients with problems of substance abuse, support services for their families and liaison with other County, local and community agencies for referral purposes. Work also involves a great deal of community interaction in communicating and gaining acceptance of the goals of the program. This position is distinguished from the Case Manager I (Substance Abuse) position by responsibility for handling more complex cases and cases with multiple abuse issues, as well as the requirement to possess the Credentialed Alcoholism and Substance Abuse Counselor (CASAC) certification. Supervision may be exercised over a small number of community workers, volunteers and entry level case managers. Does related work as required.

# **EXAMPLES OF WORK:** (Illustrative Only)

Prepares written reports such as progress notes, treatment plans, statistical reports, discharge plans, etc.;

Performs assessment of patients with problems of alcoholism and/or substance abuse for the purpose of gathering the social and medical history of the clients and their families;

Formulates treatment plans and conducts regular individual and/or group counseling sessions with patients and their families on an assigned caseload basis for the purpose of treatment and rehabilitation:

Conducts follow-up services to insure the continuation and success of the rehabilitation and to provide support or assistance, if required;

Contacts other County, local and community agencies (i.e., Employees Assistance Program, Domestic Violence Unit, Task Force on Women and Alcoholism, Community Mental Health Clinics, adult education groups, senior citizen groups, schools, community leaders, etc.) in order to engage their services on behalf of the patient;

Compiles reports on the progress of the patient, making recommendations for additional services which promote rehabilitation;

Attends meetings and conferences at the various community agencies mentioned above for the purpose of providing information related to client goals and objectives, and to instruct them in the dynamics of the disease of alcoholism and the special needs of clients/patients with problems of substance abuse;

Makes contacts with community agencies to explore the possibility of expanding their services or creating new programs to serve the needs of patients/clients and their families;

Conducts studies and makes recommendations for expanding or developing services for patients with problems of alcoholism and/or substance abuse;

Writes material such as pamphlets and brochures to provide the public with information regarding services provided;

## EXAMPLES OF WORK: (Illustrative Only) (Cont'd.)

Attends multi-disciplinary staff meetings to promote comprehensive treatment and rehabilitation services for the patient and their families;

May administer weekly breathalyzer tests, depending on assignment, for the purpose of detecting the presence of alcohol; administers semimonthly random urine analyses to test for the presence of alcohol/drugs and the presence of marijuana in clients;

May train, evaluate and supervise community workers, volunteers and entry-level Case Managers as required;

Uses computer applications or other automated systems such as spreadsheets, word processing, calendar, e-mail and database software in performing work assignments;

May perform other incidental tasks, as needed.

FULL PERFORMANCE KNOWLEDGE, SKILLS, ABILITIES AND ATTRIBUTES: Good knowledge of the dynamics of substance abuse and the disease of alcoholism, including both the physical and psychological effects of alcohol and drugs, both to the patient and family members, and the modern methods for rehabilitative treatment in a manner which is dependable, consistent, supportive and sympathetic; good knowledge of community, public and local agencies which provide services to alcoholics and substance abusers; skill in establishing and maintaining effective working relationships with both lay and professional persons and with people from a wide range of socio-economic and ethnic backgrounds in a stressful environment; skill in evaluating problems related to alcoholism and substance abuse and assist clients and/or their families to arrive at solutions which are workable within their individual socio-economic environment; ability to operate breathalyzer and urine screening equipment; ability to read, write, speak, understand, and communicate in English sufficiently to perform the essential duties of the position; ability to use computer applications such as spreadsheets, word processing, e-mail and database software: sensitivity; tact; discretion; resourcefulness; initiative; good judgment; physical condition commensurate with the demands of the position.

MINIMUM ACCEPTABLE TRAINING AND EXPERIENCE: Possession of a high school or equivalency diploma and either: (a) a Bachelor's Degree\* which included 30 credits in psychology, social work, sociology, rehabilitation, and/or counseling, or closely related field and one year of experience where the primary function of the position was in a narcotic or alcoholic treatment, prevention, and/or rehabilitation program, performing counseling, casework or social work for clients or patients; or (b) five years of work experience, including two years of experience as stated in (a); or (c) a satisfactory equivalent combination of training and experience as defined by the limits of (a) and (b).

#### SPECIAL REQUIREMENTS:

- 1. Certification as a Credentialed Alcoholism Counselor or Credentialed Substance Abuse Counselor, by the New York State Office of Alcoholism and Substance Abuse Services and maintain same while in the title.
- 2. Possession of a valid license to operate a motor vehicle in the State of New York will be required at time of appointment and maintain same while in the title.

#### SUBSTITUTION:

- Two years of verifiable, related, full-time equivalent volunteer experience may be substituted for each year of the general experience stated in the (b) qualification; up to four years. There is no substitution for the specialized experience.
- 2. One year of verifiable, full-time equivalent volunteer experience working directly with alcoholic and/or substance abuse patients or clients and their families under professional supervision by a qualified health professional as defined by the New York State Office of Alcoholism and Substance Abuse Services (NYSOASAS) may be substituted on a year for year basis of the experience stated in the (b) qualification; for up to four years. There is no substitution for remaining year of the specialized experience.

NOTE: Unless otherwise note, only experience gained after attaining the minimum education level indicated in the minimum qualifications will be considered in evaluating experience.

\*SPECIAL NOTE: Education beyond the secondary level must be from an institution recognized or accredited by the Board of Regents of the New York State Education Department as a post-secondary, degree-granting institution.
